## Tiered Services

### Tier 1: Free

Includes a review of the student's IEP and related documentation, a list of recommendations to advocate for inclusive opportunities, and resources to support caregivers in interactions with school and district personnel.

### Tier 2: Sliding Scale

Our support team will act as an advocate if Tier 1 fails to resolve the challenges to the student's right to inclusive education. On behalf of the student and family, the advocate will attend meetings and communicate with school and district personnel.

### Tier 3: Legal Referral

Referrals to vetted attorneys who champion inclusive education.

# Details on Tiered Services

## Tier 1: Consultation

- Address parental concerns and questions
- Review all documentation and help revise IEPs
- Share information on special education laws and procedures
- Recommend effective strategies for inclusion and assist parents in requests for services
- Assist in planning parent letters to the school district
- Provide referrals to a network of other IncludeNJ parents, training, and advocacy support resources

*Tier 1 services of up to 10 hours are provided to all families at no cost.*

## Tier 2: Advocacy

- In-depth review of IEP/504 and evaluation paperwork
- Attendance at IEP/504 and mediation meetings
- IEP preparation and goal setting
- Recommendations for assessments to request from your school district
- Assist with documentation
- Preparation for due process

*Tier 2 services are provided on a sliding scale based on Free / Reduced Lunch Income Eligibility Guidelines.*
